- Promote policies that give every American a fair shot
- Center the voters' desires and make workers the hero of the story

Unless specified, the data featured is from a June 10-13, 2025 survey of 1,637 voters in swing congressional districts conducted by Change Research. Since its founding, Future Majority has surveyed more than 220,000 voters across the nation.



# Play #1: Lead Messages with Financial Freedom



#### **KEY FINDING**

91% of voters - including 89% of Independents - agree that expanding financial freedom is essential



#### **PROBLEM**

Cost-of-living anxiety dominates: 84% say the American Dream feels unaffordable



#### **MESSAGE**

"Financial freedom means putting more money in peoples' pockets, protecting savings, and ensuring everyone has a fair shot."



#### **POLICY**

Lower costs (junk fees, PBMs, housing), expanding retirement access, helping small businesses compete



#### **EMPHASIZE WITH**

Cost of Living Independents, Suburban women, younger working-class voters

#### **KEY FINDING**

Democrats now lead on trust to clean up corruption, a swing since March



#### **PROBLEM**

84% say corruption blocks their path to a better life



#### **MESSAGE**

"Republicans talk about fiscal conservatism then steal from rural hospitals while adding \$2.4 trillion in debt. That's not conservative. That's corrupt."



#### **POLICY**

Ban congressional stock trading, set term limits, end elite self-dealing



# Play #3: Make Trump's Bill Personal and Unpopular



#### **KEY FINDING**

58% of voters more likely to oppose the bill after learning it adds \$2.4T to the deficit



#### **PROBLEM**

Some provisions are supported, but overall voters see it as a corrupt giveaway



#### **MESSAGE**

"Trump's Big Beautiful Bill is a \$2.4T scam for the wealthy and connected at our expense."



#### **POLICY**

Oppose tax cuts for the 1%, protect rural hospitals, defend food aid for children




### Voters More Likely to Oppose Based on Debt

"Trump says AI should be led by billionaires. We say AI should work for all of us - with guardrails and to help make our life better."



#### **POLICY**

Worker retraining, ethical AI oversight, small business investment



#### **EMPHASIZE WITH**

Younger voters, tech-aware metros

Democrats are seen as inhibiting growth and need to address this perception



#### **MESSAGE**

"Let's build more homes, more energy, more innovation - because we don't have a scarcity problem, we have a regulation problem."



#### **POLICY**

Build housing and infrastructure, cut red tape, and show visible progress – especially Governors




#### **EMPHASIZE WITH**



#### **MESSAGE**

Recognize voters' feelings, name villains (greed, tariffs chaos), center American workers



#### **POLICY**

Use stories, avoid jargon, go direct and focus on impact







Support a secure border and an efficient immigration system












### **Voters Strongly Agree with Rooting Out Corruption**


### Likelihood to Vote for Based on Statement








#### Perception of Stability in America and the World




#### Satisfaction with the Direction of America









#### **Congressional Job Approval**




































#### Concern about a President Ignoring a Court Order

If a sitting President or their Administration refuses to comply with a court order, how concerned would you be?




#### Independents Split on Efforts to Stop ICE Enforcement

Do you support or oppose members of local communities standing up and protesting and attempting to block ICE from arresting people who have broken no laws?


































#### **Voters Broadly Concerned About National Debt**









The survey of 1,637 voters was conducted by Change Research from June 10-13, 2025. Respondents were recruited via dynamic online sampling to obtain a sample reflective of the population. Post-stratification performed on age, gender, race/ethnicity, education, region, and 2024 presidential vote.

Districts included in the survey are: AZ-01, AZ-06, CA-13, CA-22, CA-40, CA-41, CA-45, CO-08, IA-01, IA-03, ME-02, MI-07, MI-10, NE-02, NC-01, NM-02, NY-04, NY-17, OH-09, OH-13, PA-07, PA-08, PA-10, TX-34, VA-02, WA-03, and WI-03.
